In December we will move \$265.49 (2% of donations) to our reserve fund, and \$167.20 from BFOF to the General fund to cover the Pod rental for October. Income from class/building use in November was \$475.00. Bookstore income was \$95.16. Hospitality income was \$121.39, and garden and flower team income was \$130.

We will tithe \$ 1,327.46 in December, based on November donations. Our floating tithe of \$331.86 will go to The Salvation Army of Dane County, which provides shelter services for women and families, housing support, disaster services, and community center youth programming. We also tithe monthly to Unity Worldwide Ministries, Great Lakes Unity Regional Council, Silent Unity, Porchlight, and the Minister's Discretionary Fund.

Our YTD General Fund Income is \$3,061 below 2022 YTD General Fund Income. When we include the \$81,139 income towards the Capital Campaign this year, our overall income for the year is \$214,610, which is \$69,885 more than YTD 2022 income. Maintaining this total level of income next year will support a full time minister and overall operating budget, as well as helping us complete our capital projects.. Please note that the Capital Campaign income does include a \$40,000 bequest that we chose to add to BFOF. Without that, our BFOF donations would be \$41,139 for the year.

We are prosperous, and grateful for the flow of income and tithing of talents. Thank you for your ongoing support of our ministry through your generous tithes and offerings, and for your vision and intention as we prepare to welcome our next permanent minister to our community.
