It is a wonderful demonstration of the prosperity consciousness and generosity of this congregation that our income exceeded our expenses for the year by \$11,254, or \$22,101 when including income from the Capital Campaign. Thank you!

As of the end of December, we have received **\$71,878** in commitments over the next three years to pay for those projects (Skylight and parking lot replacement, and audio-visual and walkway upgrades), and opened a \$75,000 line of credit to help with any gaps between Capital Campaign donations and costs. As of December 31st we had **\$20,416.31** in donations towards the campaign, giving us **\$42,756.18** in our BFOF accounts,after making a \$9,000 down payment towards the skylight replacement and paying the line of credit closing fees. Our operating income exceeded our operating expenses by \$1.229.18 for December, so we will move \$334.46 to our reserve fund. Income from class/building use in December was \$478..Bookstore income was \$188.05. Hospitality income was \$24.25.

We will tithe \$1,187.37 in January, based on December donations. Our floating tithe this month will go to Agrace Hospice, in honor of several congregants who recently passed away and received their services.

As always, we also tithe monthly to Unity Worldwide Ministries, Great Lakes Unity Regional Council, Silent Unity, Porchlight, and the Minister's Discretionary Fund that supports congregational needs.

We are prosperous, and grateful for the increasing flow of income and tithing of talents. Thank you for your ongoing support of our ministry through your generous tithes and offerings, and for your vision and intention as we draw our next permanent minister to our community, and provide funding for building and grounds improvements.
