In November we will move \$205.20 (2% of donations) to our reserve fund, and \$163.62 from BFOF to the General fund to cover the Pod rental for September.Income from class/building use in October was \$551.00.Bookstore income was \$155.14. Hospitality income was \$114.08.

We will tithe \$ 1,025.99 in November, based on October donations. Our floating tithe of \$256.50 will go to Doctors Without Borders, which provides apolitical medical services globally. We also tithe monthly to Unity Worldwide Ministries, Great Lakes Unity Regional Council, Silent Unity, Porchlight, and the Minister's Discretionary Fund.

Our YTD General Fund Income is \$4976 below 2022 YTD General Fund Income. Including the \$79,996.58 income towards the Capital Campaign this year, our overall income for the year is \$199,293.83, which is \$75,021 more than YTD 2022 income. Maintaining this level of income next year will support a full time minister and overall operating budget. Please note that the Capital Campaign income does include a \$40,000 bequest that we chose to add to BFOF. Without that, our BFOF donations would be \$40,021 for the year. Total Net Revenue YTD is (\$17,982.84), which reflects the \$54,256 we paid to contractors for completing the skylight and parking lot projects in October.

We are prosperous, and grateful for the flow of income and tithing of talents. Thank you for your ongoing support of our ministry through your generous tithes and offerings, and for your vision and intention as we prepare for our next permanent minister to our community, and also provide funding for building and grounds improvements.
